979X'S "INSTA FREE FRIDAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WBSX ("Station"), 600 Baltimore Drive, Wilkes-Barre, PA 18702, during available business hours Monday through Friday, on the Station website www.979x.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **979X's "Insta Free Friday**" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - (c) Include in the comment: #contest.
