979X'S "TEXT TO WIN 979X PRESENTS FALLING IN REVERSE TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the **979X's "Text to Win 979X Presents Falling in Reverse Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

- 4. Winner Selection. On or about 11:00am ET on Tuesday, May 28, 2024, Station will select FIVE (5) potential winners in a random drawing from among all valid entries received by Station during the Contest Period.
