979X'S "WHAT'S ON TAP TUESDAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WBSX-FM ("Station"), 600 Baltimore Drive, Wilkes Barre, PA 18702, during available business hours Monday through Friday, on the Station website www.979x.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **979X's "What's On Tap Tuesday"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the last **90 days**, and whose immediate family members or household members have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the Station in the last **30 days** or a prize valued at \$500 or more in the **90 days**. - How to Enter and Win. Listen to the Station during the Contest Period. Between 10:00am ET and 3. 3:00pm ET each Tuesday (each, a "Selection Day"), when the Station plays sounder (each, the "Sounder"), listeners must call the Station at 1-866-207-6257. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules and be qualified for the GRAND PRIZE. On or about 1:00pm ET on each Tuesday, June, 18, 2024; July 23, 2204; and August 27, 2024 one (1) grand prize winner will be randomly selected from all qualifying winners received by Station during the Contest Period and may be awarded the grand prize subject to verification and compliance with these Contest Rules. All entries may be played on the air. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest onair may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. LIMIT ONE PRIZE PER PERSON.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize.
