979X'S "INSTA FREE FRIDAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WBSX ("Station"), 600 Baltimore Drive, Wilkes-Barre, PA 18702, during available business hours Monday through Friday, on the Station website www.979x.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **979X's "Insta Free Friday"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 3. **How to Enter.** There is one way to enter.

Instagram: Entrants must:

- (a) Visit the Station's Instagram page at www.instagram.com/979xrocks during the Contest Period;
- (b) Tag another user on the Insta Free Friday post; and
- (c) Include in the comment: #contest.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Instagram will be deemed not entered in the Contest.

- 4. **Winner Selection.** On or about 11:00am ET on Monday, January 20, 2025, Station will select ONE (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
